

# SEA CARGO CLEARANCE SERVICE LAUNCHED

Gulftainer unveiled the latest addition to its product portfolio in the UAE. Sharjah Port of Trade (SPOT) is a new sea cargo clearance service for customers importing cargo into the UAE via the Khorfakkan Container Terminal (KCT). The service offers unparalleled connectivity between the emirates of Dubai and Sharjah, offering fast transit times and a reduction in delivery costs from port to door by as much as 80 percent. Complementing the cost and time savings, the port offers enhanced online customs clearance and a stateof-the-art facility for on-site cargo inspection, quality sampling and

testing services at the importer's premises. The new service will allow Gulftainer to set new service benchmarks and provide greater convenience to customers as SPOT geographically positions cargo in the heart of the UAE's commercial operations, significantly reducing delivery time and final mile cost. In fact, over 75 percent of the UAE's local cargo base is closer to SPOT than to any other port in the UAE. Therefore, customers can minimise time and trucking costs, as well as the environmental impact of their cargo deliveries.



#### NEW GALEX SERVICE ARRIVES AT KHORFAKKAN CONTAINER TERMINAL

Gulftainer has successfully completed the first direct call by Galex Service (GLX) at its Khorfakkan Container Terminal (KCT) in a record 3.4 hours. GLX, a premier service linking the rapidly growing markets in north and south Asia, India and the Middle East with a weekly sailing and competitive transit times, is offered jointly by Emirates Shipping Line and the Korean Marine Transportation Company. GLX became the first service to call at the KCT and benefit from the recent launch of Gulftainer's Sharjah Port of Trade (SPOT) service. SPOT is the new strategic cargo clearance option in the central trading and commercial districts within the UAE, ensuring substantial cost and time savings for customers and guaranteeing unparalleled connectivity between Sharjah and Dubai.

#### GT PARTICIPATES IN BREAKBULK MIDDLE EAST

#### **CCT ACES INSPECTION**

Canaveral Cargo Terminal in Florida has once again passed the United States Coast Guard's (USCG) annual inspection with flying colours. The inspections cover the Maritime Transportation Security Act (MTSA) which looks at standards concerning the security of the facility and CFR 126, which assesses the procedures around the handling of dangerous cargo.

CCT's MSTA Inspection recorded zero deficiencies and USCG advised that all security aspects were in perfect order; all processes and procedures were well organized.

Luke Richards, Terminal Manager at CCT said "The USCG inspectors were very impressed by our knowledge, segregation process and procedures for handling dangerous cargo, which is really satisfying as we work very hard to ensure we maintain a secure and safe environment for all our colleagues on the terminal. Overall GT USA has again maintained its perfect record for its Facility Security Plan and we are delighted to be commended for our organizational skills and the manner in which we operate our facility," he added.

#### GSCCO MARKS MILESTONE THROUGHPUT



GSCCO marks 25 million TEU productivity milestone

GSCCO, the Saudi arm of Gulftainer, marked a major throughput milestone by crossing the 25 million TEU threshold to maintain its position as the largest container handling and transshipment hub in the Red Sea region. Celebrations were held with staff and management to mark the occasion.

#### NEW CARGO HANDLING EQUIPMENT

GT Wilmington has begun taking delivery of new cargo handling equipment from several companies, including KoneCranes Inc. and Terberg Americas Inc. as it ramps up its improvements plan at the Port of Wilmington. The full equipment order includes nine 41-ton Rubber Tired Gantry (RTG) cranes, three 45-ton Reach Stackers, 16 Terminal Tractors and 35 Bombcarts which form part of a \$100 million investment in the Port during 2019. It will be introduced in a phased manner in 2019, strengthening operational efficiencies and increasing overall productivity. In line with Gulftainer's sustainability goals, and marking a first for both GT and KoneCranes, the RTGs and RAM spreaders are all-electric, thereby eliminating emissions coming from conventional diesel generators and any risk of oil contamination. Generators, to run the RTGs when out of stack, will be eliminated and new technology is being introduced by GT USA, in the form of battery packs, to eliminate

exhaust emissions completely. As an added safety feature the equipment will be fitted with KoneCranes' Active Load Control (ALC) system, which eliminates container sway, and the Stack Collision Prevention system.

The RTGs are capable of stacking containers in stacks of five high and seven rows wide, plus a truck lane to increase yard stacking capacity, while the Reach Stackers are capable of stacking containers five high. They underline our obligation to further strengthen our operations at the terminal and re-enforces the Port's credentials as the number one gateway for imports of fresh fruit and juice concentrate in North America.
