Pre-arrival Cargo Screening

Dear Valued Customers,

This advisory should be read in conjunction with the previously issued Cargo Prioritization Advisory relating to Khorfakkan Port.

Gulftainer is pleased to announce the launch of the **UAE Cargo Intelligence (UCI) system**, a cargo screening platform designed to enhance security, compliance, and operational efficiency across our terminal operations. The UCI system will analyze all inbound cargo by reference to the declared commodity description, HS code, and consignee details in order to support operational planning and decision-making in relation to vessel berthing, cargo acceptance, and terminal handling at our facilities.

Mandatory Manifest Submission

With immediate effect, all Shipping Lines and their appointed agents are required to submit a complete and accurate cargo manifest no later than two (2) hours after departure from the last port of call prior to arrival at any Gulftainer-operated terminal. The manifest must include, at a minimum, the full commodity description, HS code classification, and consignee particulars for each shipment.

Gulftainer reserves the right to refuse berth, amend vessel sequencing, withhold cargo handling, or cancel any confirmed berth allocation where reasonably required due to incomplete, inaccurate, misleading, or late manifest information.

Additional Mandatory Requirements

In conjunction with the implementation of UCI, the following shall apply :

- For the avoidance of doubt, the operational restrictions previously notified by Gulftainer, including those relating to restow operations, hazardous cargo, and out-of-gauge cargo, remain in full force and effect unless and until otherwise notified.
